Mr President begins the meeting by asking if all the attendants had received the minutes of the last meeting by email, and reminding that because of the current COVID19 situation, social distance must be kept at all times. After confirming that all of the attendants had received a copy of the minutes, the President decides not to read it again. Then he briefly explains the content of the present agenda, and proceeds to the election of the President, Secretary-Administrator and Committee.

Initially, Mr Joseph Maxwell is suggested for the President position, Mr. David McMillan for Secretary-Administrator, and Mr Thorsteinn Thorsteinsson y Mrs Astrid Synnove Knain for the Committee. The attendants vote unanimously for the mentioned positions, with no abstentions and no alternatives for any of the positions.

Next, the President proposes that an authorization for the Community's bank account should be given to three members of the Committee, and it will be required that two of those members sign electronically to make payments from the bank account. This procedure is chosen so that no urgent payments are delayed in case that any of the three members are unavailable. It is suggested that Mr Joseph Maxwell, Mr David McMillan and Mr Thorsteinn Thorsteinsson are the three authorized members. Also, the President explains that from now on, all of the contracts and invoices of the Community will be published on the website for transparency purposes. The attendants vote unanimously for the bank account authorization of the three members.

It is also unanimously voted for the refund to Mrs Astrid Synnove Knain, who paid a total amount of 1260.85€ for the purchase of gardening materials for the Community.

Finally, the President explains that another Community Meeting will be convened in the month of January, to discuss the financial situation, the plans for the future and the Budget for 2021. He also reminds that the same bank account will be used in the future, and that the legal representatives of the Community will not have access to it. Lastly, Mr President expresses his will of serving the Community in the best way possible, along with the Vice-president and the Committee.
